Manuscript Submission Information

The journal accepts only completed manuscripts and only those that are not concurrently under review by another journal or other publication. All submissions must be suitable for an interdisciplinary audience. As such, they must be clear and jargon free while retaining their academic rigor. All submissions must be sent electronically. Papers must be Microsoft Word documents and attached to an email sent to submissions@williamjamesstudies.org. Manuscripts should be double-spaced and no longer than 8,000 words, including references. On questions of style and documentation, each manuscript must be consistent with the 17th edition of *The Chicago Manual of Style* and include a bibliography and endnotes (we do not accept footnotes). All manuscripts must be accompanied by an abstract, no longer than 150 words. Because unsolicited manuscripts are blind reviewed, each must include a separate title page listing the title of the paper, the author's name, institutional affiliation, word count, and current contact information. There should also be no references in the paper or endnotes that

compromise the anonymity of the author. Although we try to provide a quick turnaround, authors can expect a decision regarding their submission within four months.

Book Review Submission Information

WJS will consider unsolicited book reviews of 800-1000 words on topics consistent with the journal's Mission Statement. In addition, we welcome short reviews (400-500 words) that offer a concise, cogent overview and evaluation of the book under consideration. All reviews should be submitted not more than three months after receipt of the book. The Editors welcome suggestions of books for review; prospective reviewers should indicate their interest in being considered for review assignments.
